NOVEMBER AIRLINE PASSENGER OPERATING STATISTICS

Passenger numbers for the month increased by 11.57% over the previous year. Skywest traffic, measured by Revenue Passenger Kilometres (RPKs) increased by 9.61%, while capacity, measured by Available Seat Kilometres (ASKs) increased by 4.75% over the same period. Load Factor increased by 2.58 pts to 58.34% compared to the previous year.
